## **Special Suicide Clause**

When the proponents have a personal history of mental retardation such as schizophrenia, catatonia, depression etc. (CO.Cir. ACTL/1424/4 dtd.20/8/88).

## Note:

- 1. Where a lady is having a history of Miscarriage or abortion or she has undergone a caesarian operation for child birth, risk of death due to pregnancy shall be excluded by charging single extra prem. According to the plans.
  - Under Jeevan Saathi (T.89) and Jeevan Sarita plan (T.117) single extra of RS.2%0 to be charged compulsorily for only one caesarian operation, if two caesarian plan not granted.
- 2. Under Plans -122 (Jeevan Suraksha), single extra of Rs.2%0 must be charged in place of CL.6
